

**CONTRACT AMENDMENT NO. 4

This Contract Amendment No. 4 to Williamson County Contract for Engineering Services (“Amendment No. 4”) is by and between Williamson County, Texas, a political subdivision of the State of Texas, (the "County") and HNTB Corporation (the “Engineer”).

**RECITALS**

**WHEREAS**, the County and the Engineer previously executed that certain Contract for Engineering Services (the “Contract”), being dated effective December 17, 2019, wherein Engineer agreed to perform certain professional engineering services in connection to construct various road and drainage projects (“Project”);

**WHEREAS**, it has become necessary to supplement, modify and amend the Contract in accordance with the provisions thereof.

**I. Amendment to Exhibit C - Rate Schedule**

All other terms of the Contract and any prior amendments thereto which have not been specifically amended herein shall remain the same and shall continue in full force and effect.


