Hold public hearing on Re-subdivision of Lot 26, South San Gabriel Ranches.

At 10:10 a.m., Judge Doerfler announced public hearing open on Re-subdivision of Lot 26, South San Gabriel Ranches.

Commissioner Boatright advised Avon Curtis Stone, owner of 17.29 acres, is selling 10.21 acres to D & M Developments Joint Venture and is being divided into 16 one-half acre tracts.

Residents of the area including Mike and Mary Ellmore, Walt Favor and Jean Gardner spoke against approval of the re-subdivision.

T. J. Hillis advised there were no subdivision restrictions of record prohibiting the 1/2 acre tracts.

Commissioner Boatright advised the plat lacked a signature block for Sandy Creek Water System to sign as the water source for the re-subdivision. He also requested Paulo Pinto of the Health District contact the State of Texas regarding the present source of water and existing regulations.
