WHEREAS, The Williamson County Commissioners Court has entered into a contract with the State of Texas to execute a Texas Community Development Program Project, and


WHEREAS, Williamson County must designate certain individuals authorized to sign certain contractual documents required by the Texas Community Development Program,

The authorized signatories for the Request for Advance Reimbursement are the County Judge, the Administrative Assistant to the County Judge and Commissioner David Hays.

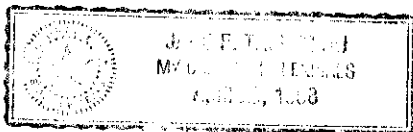


Dear Sirs:
