Hear any interested persons, consider forming the next agenda, or adding any emergency items to today's agenda.

Terry Davis addressed the court concerning property owned by Commissioner Boatright north of State Highway 29 in the path of the proposed extension of Parmer Lane.

Mr. Davis also informed the court that a citizen on County Road 272 complained about the surveying of 150 feet onto his property, stating that Parmer Lane is supposed to be 200 feet right-of-way for the road to go through. The report submitted by County Engineer Joe England states the survey is 200 feet.

Mr. Davis requested an item on the agenda voting on the alteration of County Road 272 so issues can be addressed pending the District Attorney's investigation.

Mr. Davis questioned Judge Doerfler on his intentions regarding County Road 272 lining up with the former Parmer Lane project going through property owned by Commissioner Boatright or this becoming a no action item?

Mr. Davis stated the southern portion of Parmer Lane is the exact route on County Road 272 which is being surveyed at 200 feet.

Judge Doerfler will contact County Engineer Joe England about the surveying on County Road 272 and where the 150 and 200 feet are coming from.

Mrs. Gretchen Mickler addressed the court with four requests and petitions signed by neighbors along County Road 270 from State Highway 183 to the end of Orchard Lane.

1. Request the Williamson County Road & Bridge Department to install signs on County Road 270 which would indicate the various school bus loading zones.
2. Request Williamson County Road & Bridge Department install a sign indicating a dangerous curve.
3. The speed limit on County Road 270 be reduced from 40 mph to 30 mph for the safety of the children in the neighborhood.
4. Request information on starting a neighborhood watch association.
