Hear any interested person and consider forming the next agenda or adding items to today's agenda.

Northridge Acres resident Ken Snyder addressed the court with his displeasure over the county ditch cleaning performed in his subdivision last week. However, he was pleased with the grass cutting job.

Judge Doerfler acknowledged Mr. Snyder was entitled to his opinion but he believed Commissioner Heiligenstein and Commissioner Assistant Julie Lyon were doing everything possible to expedite the program for Northridge Acres. "It will work with the cooperation of the community but will not without their cooperation." He continued with the county (unlike cities) was limited in what work can be performed. He understood the concern of Mr. Snyder and appreciated his attendance to keep the court updated. The Judge felt if Mr. Snyder and the other residents would work with Commissioner Heiligenstein and Miss Lyon much could be accomplished.

Mr. Snyder asked what the large "X" painted on the street in front of his home represented. Commissioner Heiligenstein advised this was probably a control point for an aerial survey for State Highway 45 and the City of Austin water lines.

Commissioner Heiligenstein advised a meeting of county representatives (Commissioner Heiligenstein, County Engineer Joe England, First Assistant County Attorney Dale Rye and Williamson County and Cities Health District, Paulo Pinto) is being held this afternoon to discuss the Northridge Acres project. Also, he offered Mr. Snyder a copy of the minutes from the meeting of April 20, 1999.

Williamson County and Cities Health District Environmental Division Paulo Pinto reported on the successful Household Hazardous Waste Collection Day Saturday, April 24, 1999. Mr. Pinto hoped since only 450 cars drove through the line, the county residents were finally beginning to clean out their garages and dispose of their hazardous waste.
