Hear comments from commissioners.

Commissioner Heiligenstein reminded the court of CUC meeting next week and discussed the ending of the State Legislative session. He asked how many members of court were attending the National Association of Counties (NACO) St. Louis meeting in July - (he and Commissioner Hays).

Commissioner Heiligenstein met with Turnpike Authority last week with Pete Winstead and new member Phil Russel who can't really tell Williamson County a lot about State Highway 45 right-of-way until they have actually completed their designated routes, all the environmental and then submission of information to the Feds. Officially they cannot direct Williamson County so the commissioner felt any tracts purchased should be purchased with the thought of selling if they were not needed for right-of-way.

After working with Information Systems for the past 6 months Judge Doerfler feels the department under staffing should be addressed in the 1999/2000 budget.

County Attorney Gene Taylor reported the new magistrates bill was passed on May 30, 1999, and is awaiting signature of Governor George W. Bush. The District Court bill has also passed and can begin January 1, 2000. The County Court-at-Law bill passed and can begin operation September 1, 1999.

Judge Doerfler suggested the new County Court-at-Law court room plus 2 offices be built on the site of existing Law Library at 405 Martin Luther King Boulevard. Then construct a temporary/permanent structure to house law library in parking lot of Williamson County Annex.

Judge Doerfler thanked County Attorney Gene Taylor for all his time and attention to the magistrates, new County Court-at-Law and new District Court bills passed by the Texas Legislature this session.
