I respectfully request your consideration and approval of Mr Hebert Alonzo as non-paid deputy for the Precinct Three Constable's staff This item is requested for the October 19, 1999 Commissioner's Court agenda

Mr Hebert Alonzo was formerly employed by the Taylor Police Department for one year under a Juvenile/Gang enforcement grant program The position was lost when the grant expired through no fault of Mr Alonzo He had prior experience as a non-paid peace officer in Taylor, Texas, Round Rock, Texas and Copperas Cove, Texas. The background investigation revealed a dedicated, hard working, knowledgeable, and bilingual skilled individual He holds a basic peace officer license, in addition to private pilot and airframe licenses with the FAA. His full-time employment is well established in the semiconductor processing industry

Mr Alonzo's full-time work schedule would allow his contribution to the Constable's Office to be during weekday daytime hours It is this time period that our workload is taxed the most where Mr Alonzo's non-paid Deputy Constable status would be most useful His education, experience and ability to work independently as a basic peace officer makes him a valuable addition to the Constable's staff
