This notice is to inform you that as the owner of the above property in the Southeast Williamson County Road District you must pay \$ 5,595.34 to the Southeast Williamson County Road District on or before January 31, 2000. **IF YOUR MORTGAGE COMPANY MAINTAINS AN ESCROW ACCOUNT FOR THIS ASSESSMENT, PLEASE FORWARD THIS STATEMENT TO YOUR MORTGAGE COMPANY. IT IS STILL YOUR RESPONSIBILITY TO INSURE THAT PAYMENT IS MADE ON TIME.**

The Williamson County Commissioners Court established the Southeast Williamson County Road District in order pay off bonds issued for road improvements in this area. To pay off the bond debt, the District requires annual installment payments from the owner of this property. These payments are secured by a lien on the above property. If the amount due is not paid by the due date, the District has the right to accelerate the maturity of the remaining installments and declare the entire unpaid balance of the lien due and payable.

Payments become delinquent on February 1. Finance charges will be added monthly beginning February 1 per the following chart:
