I respectfully request your consideration and approval of Mr. Shannon Houston Saffel to fill the newly created Deputy Constable position (Warrant Officer) for the Precinct Three Constable's staff. This item is requested for the October 3, 2000 Commissioner's Court agenda, so that I may offer employment as soon as possible after the beginning of the fiscal year.

A Selection Team was comprised of two individuals from outside law enforcement agencies and one individual representing business and community. I followed the Selection Teams recommendation after they reviewed twelve applicants that resulted in eight finalists advancing to an interview. The Selection Team unanimously chose Mr. Saffel.

Mr. Saffel has four years experience with the Texas Department of Criminal Justice with inmate control at a high-risk correctional facility.
