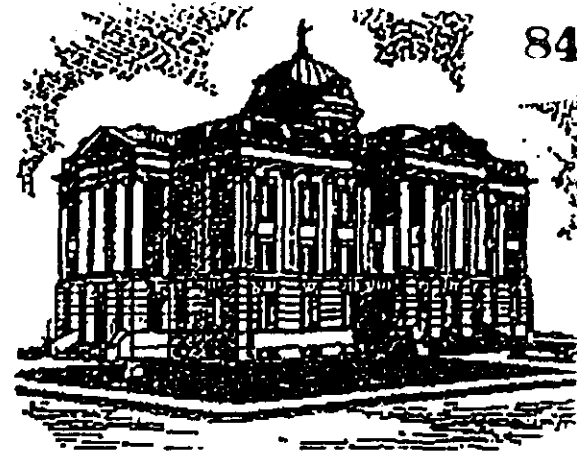

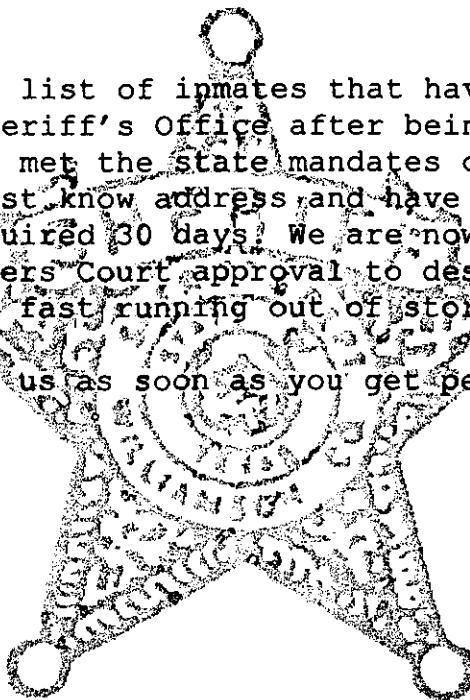
Dear Bob,
