**WHEREAS**, the County of Williamson desires to assist people with disabilities to achieve homeownership; and

**WHEREAS**, the Texas Home of Your Own Coalition sponsored by United Cerebral Palsy of Texas is a resource and advocacy program to assist people with disabilities in pursuing homeownership; and

**WHEREAS**, the Texas Home of Your Own Coalition has been in existence since 1995, and is a partnership among lenders, realtors, homebuilders, disability advocacy organizations and housing organizations; and

**WHEREAS**, HOME funds for this purpose are currently available from the Texas Department of Housing and Community Affairs; and

**WHEREAS**, United Cerebral Palsy of Texas is desirous of applying for these funds to enhance homeownership opportunities for people with disabilities in Bastrop, Blanco, Burnet, Caldwell, Hays, Travis and Williamson counties.

**NOW THEREFORE BE IT RESOLVED** that the County Commissioners of the County of Williamson supports the application of the United Cerebral Palsy of Texas to the Texas Department of Housing and Community Affairs for \$150,000 in HOME funds to provide down payment assistance for persons with disabilities.
