Williamson County Health Officer for Rabies Control Mahlon Arnett appealed to the court to make the public aware of the State law requiring all dogs and cats to receive a rabies shot once a year from a licensed veterinarian and the Williamson County ordinance requiring all dogs to be under the control of their owner at all times and must be licensed. He suggested this be done at no cost to the county by sending a memo to all county employees, and request all builders and realtors to notify their clients of these State and County laws.

He had a pamphlet which he suggested re-printing and posting in as many public places as possible. He would also like to see the news media publish this information periodically as a public service.

Williamson County Historical Commission Chairman Mrs. Irene Varan thanked the court for their donation of time, talent and treasure for conserving the heritage of the people of Williamson County, Texas, and improvements to the Historical Museum, while presenting framed certificates to each member of the court. She invited all to visit the museum between the hours of 10 a.m. to 2 p.m.

Over the Hill Gang President Suzi Bates thanked the court for the use of and some maintenance on the building at 3407 Ranch Road 1869 in Liberty Hill which they share with the Williamson County Sheriff's Department. She extended an invitation to the court to visit June 17, 2000, for the VFW fish fry to help celebrate the 2<sup>nd</sup> anniversary of the Gang.
