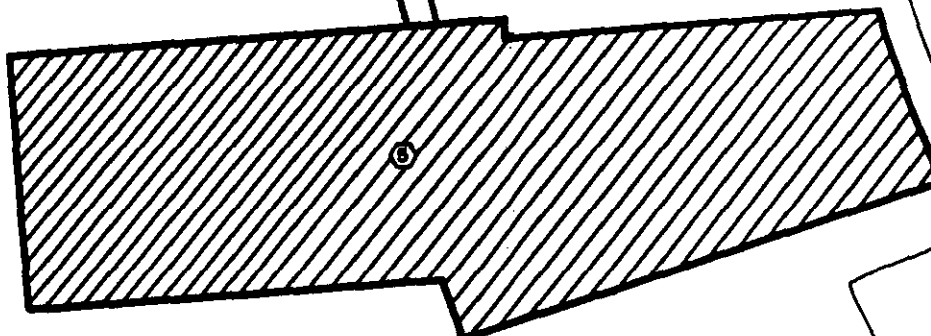
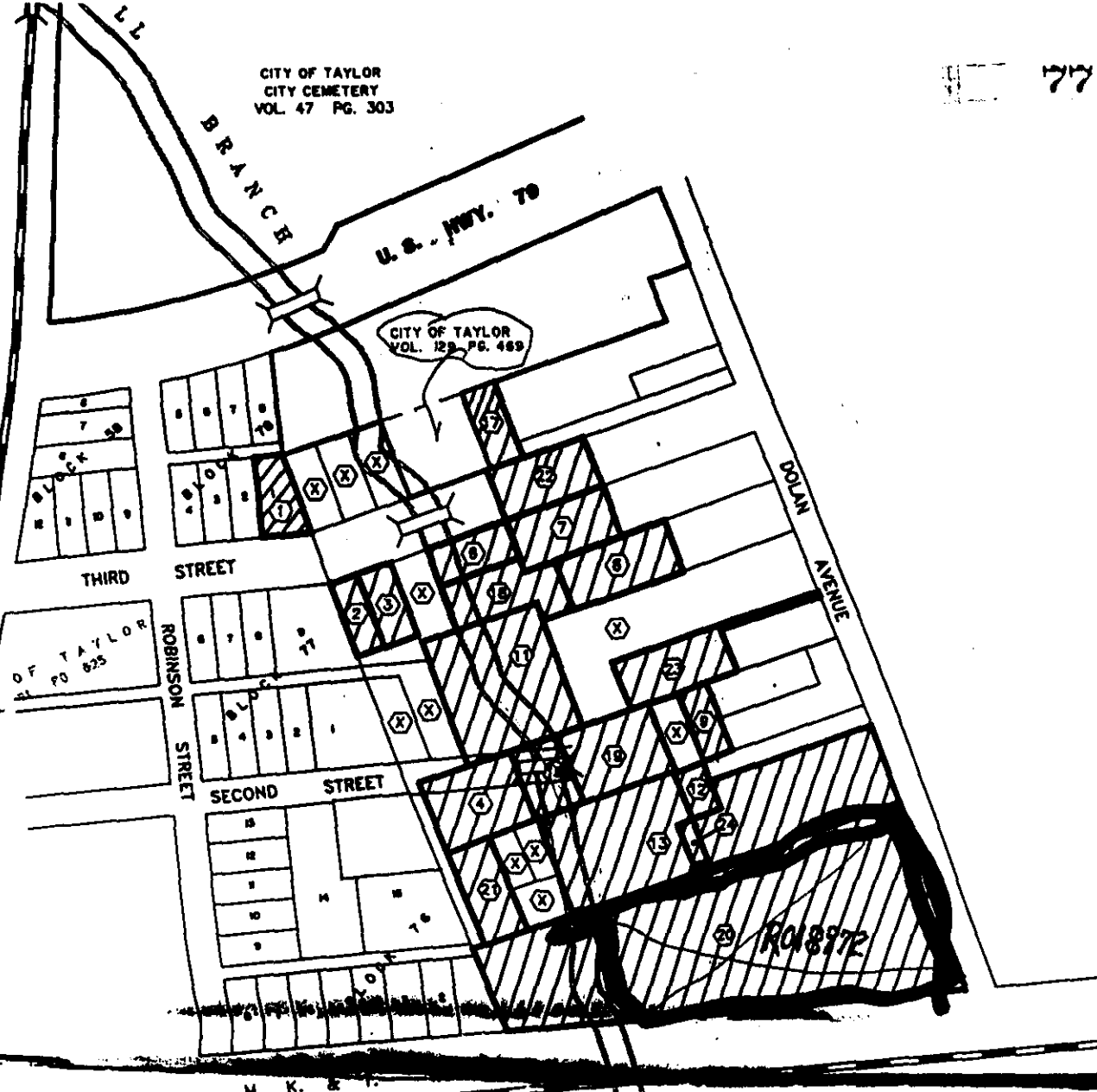

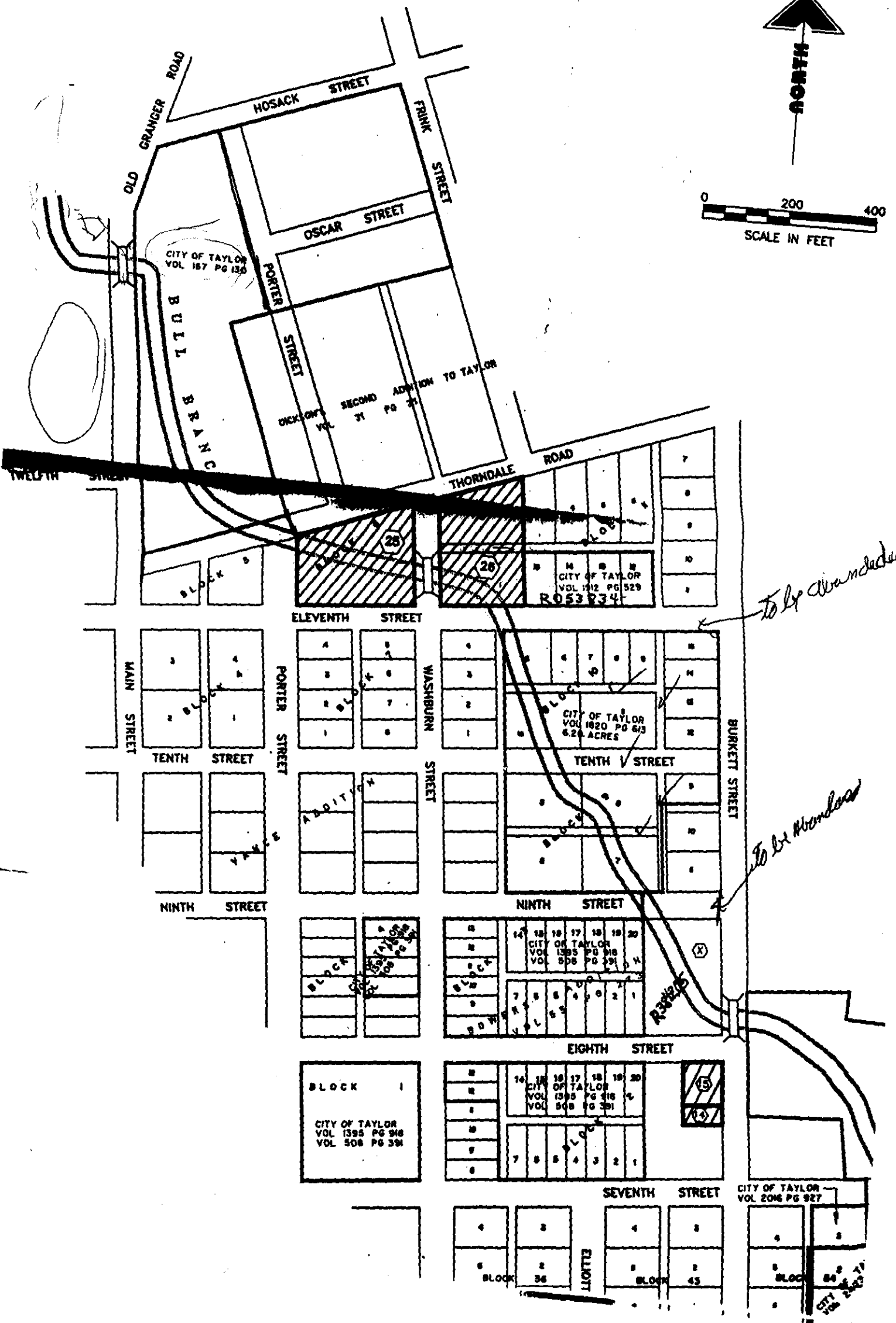

The Williamson County Activity Center is and has always been very grateful for the support the County gives our organization.


All the money the County has donated to the Center has been applied to our operational needs. Our 2000-2001 budget is as follows:
