Commissioner Boatright reported on weekly meetings with Landmark Construction followed by expansion discussion but no action was taken on this item.

**AGENDA ITEM 34****Discuss and take any appropriate action on road bond projects.**

Prime Strategies Mike Weaver addressed the court regarding cash flow schedule. He suggested a \$50M to \$60M bond sale rather quickly would carry the current interest rate with 2% tax increase and carry the program in excess of a year. Inner Loop, Parmer Lane, 79 and individual precinct projects could begin with these funds.

Mr. Weaver also suggested the court put into writing their position on funding time and frontage roads along SH 45 and 183.

The third item would be determining the financial framework. Since the engineering proposals are due Wednesday, December 20, 2000, he suggested a January 9, 2000, work session. This would allow time for review and possibly decisions made.

Mr. Weaver also suggested Alan Glen and Steve Paulson continue to work on these projects. "We have a long way to go obtaining clearance from Corps of Engineers and Fish and Wildlife issues on Parmer Lane. The process should begin as soon as possible and would probably require 90/120 days for exploratory work building on the process Commissioner Hays has already accomplished. They would be responsible for a definite plan as well as expense of the project." Prime Strategies has estimated \$10M for environmental litigation.

Commissioner Boatright has volunteered to work with CAMPO and TxDOT, Commissioner Heiligenstein with TTA and Commissioner Hays with Fish and Wildlife.

Mr. Weaver recommended County Judge John Doerfler be authorized to enter into a new agreement with attorney Charles Crossfield to act as Right-of-Way Manager. The county attorney is to review all agreements and contracts but would like the authority to use Charlie Crossfield if needed. Charlie's agreement will be put on the agenda for January 9, 2001, for approval. Commissioner Boatright expressed that he would like to see Mike Weaver's contract finalized and agreements with the cities involved in the projects inside their city limits and timelines.
