- Hold a Public Hearing for the purpose of discussing the allocation of the FY 2001 LLEBG grant funds and complete the Public Hearing certification page (Not Applicable for State jurisdictions)
- Establish an Advisory Board with representation from all of the **required** members; convene at least one Advisory Board meeting and complete the Advisory Board certification page (Not Applicable for State jurisdictions)
- Complete the Project Information by naming and describing all projects to be funded with FY 2001 LLEBG funds; assign each project to one of the seven Purpose Areas; and provide project specific information for each project
- Complete Allocation Information including details by Allocation Category for all LLEBG funded projects
