RECITALS

WHEREAS, the Southwest Williamson County Road District No. 1 (the "District ") has received a request from the owners of certain real property within the District to consider the re-assessment of District debt against said property, and,

WHEREAS, the District convened a hearing on the 11th day of September, 2001, at the request of the owners. A representative of the owner appeared in person and was given an opportunity to speak or present evidence regarding the proposed re-assessment.

FINDINGS


The Board of Directors of the District finds and determines as follows:

1. That all conditions, provisions and actions taken in the Order Approving the Assessment Plan for the Southwest Williamson County Road District No. 1, recorded in Volume 0059, Page 640 of the Commissioners Court Minutes of Williamson County, Texas remain in full force and effect.
2. That the following described real properties are located within the District:

Tract 1: WCAD PID Account # 399388, being Lot 1, Block A, LAKELINE VILLAGE, SECTION THREE

Tract 2: WCAD PID Account #102653, being Lot 2, Lodge at LAKELINE VILLAGE II
3. That Tract One shall be assessed in the sum of \$10,066.38
4. That Tract Two shall be assessed in the sum of \$43,249.82.
5. That upon payment of the above sums, a release shall be executed releasing said properties from all District debt.

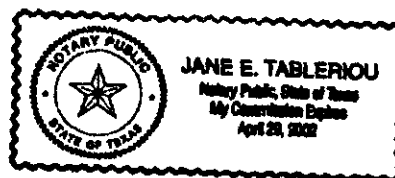
