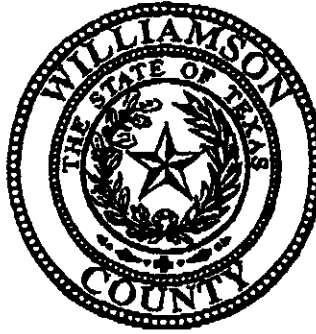

- Mechanically attach tapered polyisocyanurate and perlite fill for crickets where designated on the roof for the proper drainage around buildings and RTU's.
