RESOLUTION

STATE OF TEXAS

Know All Men By These Present

COUNTY OF WILLIAMSON

On this the 21st day of August, 2001, a duly called and lawfully convened meeting of the Commissioner's Court of Williamson County, Texas was held in the City of Georgetown. A quorum of the Members were present to wit:

where, among other matters, came up for consideration and adoption the following Resolution:

Whereas, House Bill 177, passed by the 77th Texas Legislature effective on September 1, 2001, adds Article 102.0173 of the Texas Code of Criminal Procedure; and

Whereas, Article 102.0173 of the Texas Code of Criminal Procedure authorizes the Commissioners' Court of a county to create a Justice Court Technology Fund effective September 1, 2001, and furthermore authorizes the Commissioners' Court to require a defendant convicted, as defined by this article, in a misdemeanor offense in a justice court to pay a fee not to exceed \$4.00 as a cost of court and further authorizes the collection of this fee for offenses committed on or after September 1, 2001 and through September 1, 2005; and

Whereas, the justice court clerk shall collect the costs and pay the funds to the county treasurer for deposit in a fund to be known as the justice court technology fund and furthermore authorize; and

Whereas, a fund designated under the above article may be used only to finance the purchase of technological enhancements for a justice court, including: computer systems, computer networks, computer hardware, computer software, imaging systems, electronic kiosks, electronic ticket writers and docket management systems; and

Whereas, the justice court technology fund shall be administered by or under the direction of the commissioners court of the county.

Therefore Be It Resolved that the Commissioners' Court of Williamson County, Texas does hereby authorize and require each Justice Court of Williamson County to assess and collect a fee of \$4.00 on each conviction, as defined in Article 102.0173 Code of Criminal Procedure, of a fine only misdemeanor committed on or after September 1, 2001. The Commissioners' Court of Williamson County further orders that the Justice Courts of Williamson County deposit the fees collected with the County Treasurer to be deposited in the account of the Justice Court Technology Fund. This account will be administered by the Commissioners' Court of Williamson County and used only as designated by Article 102.0173 Code of Criminal Procedure. This order will expire September 1, 2005.

And Further Be It Resolved, that the County Judge John Doerfler be, and is hereby authorized to sign this Resolution as the act and deed of the Commissioners' Court.

The foregoing Resolution was lawfully moved by Commissioner Boatright, duly seconded by Commissioner Limmer, and duly adopted by the Commissioners' Court on a vote of 4 members for the motion and 0 opposed, and/or with _____ members abstaining from voting and/or 1 absent from the meeting.
