**Course description.**

The race will start on Research Park property and do an out and back on Riata Parkway up to Riata Trace. From there it will reenter Research Park from Riata and proceed to the exit at the McNeil Road entrance. At McNeil the race will take a left and proceed west on McNeil to Los Indios. Take a right on Los Indios to the dead end on Pond Springs and take a right. Take a right on TurtleRock Rd and continue to 610. The road name changes to Broadmeade at Anderson Lane. Take a right on 620, go 1 block and turn right onto the access road and take an immediate right on Merna Lane. Continue to AmberGlenn and turn left. This will dead end into Parmer Lane (734). Take a right on Parmer and go to Tamayo Drive. Take a right and continue until it dead ends on Dallas. Take a right and continue to the first stop sign and take a left on Blackfoot. Continue until this dead ends into McNeil. Take a left on McNeil and take the first right into Research Park.
