AGENDA ITEM 35

Comments from commissioners.

Commissioner Heiligenstein discussed several meetings he attended during the last week. He met with the City of Austin on HB 1445, concerning subdivision regulations in the extraterritorial jurisdictions of cities. He said that the City of Austin will submit an interlocal proposal to the court. He also stated that the meeting with the Round Rock City Council regarding right-of-way at 1325 and IH-35 for SH 45 went well. He expressed concern about the SH 45 project being stalled because of right-of-way issues.

Commissioner Boatright stated that CAMPO recommended funding in the amount of \$5,000,000.00 for the Wyoming Springs project south of HWY 620. He said that an unexpected accomplishment from the meeting was that SH 45 would tie into SH 130 on the south end and to IH 35 south of Austin near Onion Creek.
