Our client, Bobby Fredrickson, President of the Woods of Fountainwood Ltd, has requested that we change the name of the street shown on the approved preliminary (Public Review Final Plat) of the Woods of Fountainwood Phase 3 as Wood Croft Trail to Alyssa Drive. Approximately 232 feet of Wood Croft Trail is contained on the plat of the Woods of Fountainwood Phase 2, recorded in Cabinet U, Slide 260 of the Plat Records of Williamson County, Texas


We have verified with Emil Shuka, Williamson county 911 address coordinator that Alyssa Drive is not a duplication of an existing street name in Williamson County.
