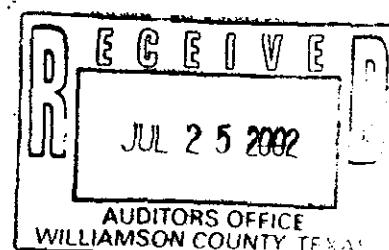

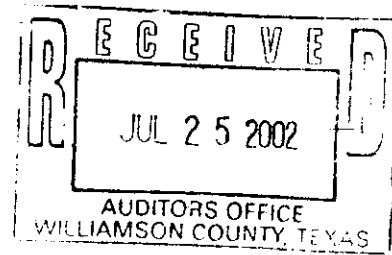

On July 22, 2002, the City Council of Liberty Hill, Texas met in an open meeting to discuss and take action on Williamson County's projected cost associated with the purchase and labor of 39 speed limit signs within the City. In a five (5) votes for and zero (0) votes against, the Liberty Hill City Council unanimously accepted Williamson County's projected cost as noted in Exhibit "A" of the attached Interlocal agreement.
