

5. WW extension to WC MUD #9	= \$148,512.10
6. Main entry Guardrail and Rip Rap	= \$ 11,385.00
7. Cost of Signage (not to exceed)	= \$ 5,600.00
8. Credit for Pump house allowance	=(\$4,457.10)
9. Credit for deletion of lift station road	=(\$4,383.81)


AGENDA ITEM 40
