This permit is valid for the operation of a vehicle within certain tolerances above legal axle and gross weight limits, as provided in Transportation Code, Chapter 621. For Agriculture Commodities only: This permit authorizes the described vehicle or vehicle combination to exceed the maximum legal axle weight by a tolerance of 12% and to exceed the maximum legal gross weight by a tolerance of 5%. This permit is valid for vehicles loaded with timber, pulp wood, wood chips, or cotton, livestock, or other agricultural products that are in their natural state; and being transported from the place of production to the place of first marketing or first processing. For Non-Specific Commodities: This permit authorizes the described vehicle or vehicle combination to exceed the maximum legal axle weight by a tolerance of 10% and to exceed the maximum legal gross weight by a tolerance of 5%. Permit is valid for both agricultural and non-agricultural commodities. This permit is not valid for the Interstate Highway System. Permit valid on all roadways on the state maintained system and all county roads in counties where the county clerk has been notified by TxDOT in accordance with Texas Transportation Code Section 623.103. It is expressly understood that the TxDOT shall not be responsible in any way for any damage of whatever nature that may result from the movement of the described vehicle over state highways, and that all such responsibility is hereby accepted on behalf of the applicant. Vehicle must be registered for the maximum gross weight as provided in Transportation Code, Chapter 502. No travel on load posted bridges with weights exceeding posted limits, unless the bridge provides the only public vehicular access from or to a permit holder's origin or destination.
