DESCRIPTION OF PROPOSAL

This change incorporates the additional work performed in Parking Lot #2 at the Williamson County Regional Park project. Sub-surface or groundwater was found to be in the general area of Parking Lot #2 after initial paving was constructed. This change includes the additional work to bridge this pre-existing condition.
