

ORDER APPROVING NEW ELECTION DAY POLLING PLACES
IN WILLIAMSON COUNTY, TEXAS

On this the 5th day of August, 2003, the Commissioners' Court of Williamson County, Texas, does hereby order the following action, effective September 13, 2003:

- (1) that the new polling place for precinct 275 be the Bethany United Methodist Church, 10010 Anderson Mill Road, Austin, Texas. The former polling place, Spicewood Springs Library is closed for renovation.
- (2) that the new polling place for precinct 301 be the Georgetown ISD Administration Building, 603 Lakeway Drive, Georgetown, Texas. The former polling place, McCoy Elementary School, has inadequate parking and is not centrally located in the precinct.
- (3) that the new polling place for precinct 305 be the Sun City Social Center, 2 Texas Drive, Sun City, Georgetown, Texas. The former polling place, Crestview Baptist Church, is no longer available to host elections.
- (4) that the *temporary* polling place for precinct 330 be the Zion Lutheran Church, 6001 FM 1105, Georgetown, Texas. The regular, full-time polling place, Walburg Community Center, has been rented and is not available on September 13, 2003.
- (5) that the new polling place for precinct 371 be the Faith Lutheran Church, 4010 Williams Drive, Georgetown, Texas. The former polling place, Crestview Baptist Church, is no longer available to host elections.
- (6) that the *temporary* polling place for precinct 390 be the Zion Lutheran Church, 6001 FM 1105, Georgetown, Texas. The regular, full-time polling place, Walburg Community Center, has been reserved and is not available on September 13, 2003.
- (7) that the new polling place for precinct 425 be the First United Methodist Church, 645 West Clark Street, Bartlett, Texas. The former polling place, Bartlett Electric Cooperative was too small for some elections and is no longer available.
- (8) that the *temporary* polling place for precinct 463 be the Round Rock Fire Station #4, 3300 Gattis School Road, Round Rock, Texas. The regular, full-time polling place, Fellowship at Forest Creek Church, does not have space available for voting on September 13, 2003.
- (9) that the new polling place for precinct 489 be the First United Methodist Church, 645 West Clark Street, Bartlett, Texas. The former polling place, Bartlett Electric Cooperative was too small for some elections and is no longer available.
