Request approval to transfer from Williamson County EMS to Precinct Four Constable's Office reference the above mentioned vehicle. The vehicle would be used to transport the bicycles used to provide bicycle safety courses to communities, and as a base of operations for community events, such as Rattlesnake Round up, Taylor Rodeo, and National Night Out. We run into problems trying to carry the traffic cones needed to close off areas for bike rodeos, the inverter could be used to recharge batteries for handheld radios, and batteries for lights and sirens on the bike units used for major community events, and carry all of the other necessary equipment required to put on a bike rodeo. Commissioner Limmer has approved a location at the Taylor Maintenance Facility for the unit, when it is not in use. We plan to utilize the unit as long as it will carry us, and plan to turn it over to auction if any major repairs arise (i.e.: transmission failure, major engine repair, etc.). This will alleviate any impact on vehicle repair line item, other than routine maintenance.
